## Legal Aid NC Offers Continuing Legal Education (CLE) for Attorneys

We routinely sponsor free or low-cost continuing legal education (CLE) sessions for attorneys who want to learn more about public interest law or become a pro bono volunteer.

Titles of recent offerings include "Wipe Out: Handing Expunctions the Easy Way"; "National Origin Discrimination, the Fair Housing Act, and Enforcement"; and "Long-Term Care for All: Identifying & Reducing Inequities in Long-Term Services and Supports (LTSS) Access."

Most CLEs are currently offered by webinar. Costs range from free for Legal Aid NC staff and volunteers to \$65 or more. We encourage lawyers not currently on the Legal Aid NC staff to utilize our CLE program to learn more about public interest law.

### Legal Aid NC Founding President and Executive Director, George R. Hausen, Jr., Retires

After 20 years of service, George R. Hausen, Jr., recently retired. "Leaving Legal Aid is truly bittersweet for me," he said. "My 20 years here have been the most meaningful of my career. The passion, dedication, and tirelessness of my colleagues—not to mention the resiliency and courage of our clients—inspire me daily."

Under Hausen's visionary leadership, Legal Aid NC's staff grew from 220 to 475. The operating budget almost tripled and now stands at \$38 million. We're one of the largest human service nonprofits in the state, the third largest law firm, and one of the biggest civil legal aid organizations in the country. Legal Aid NC staff has served hundreds of thousands of households since our inception in 2002.

During Hausen's tenure, we launched numerous innovative projects and strategies to provide holistic services to clients. These include the NC Navigator Consortium, which helps enroll North Carolinians in affordable health insurance on HealthCare.gov, and the Disaster Relief Project (see p. 13 for detailed info).

We also established our Central Intake Unit to standardize client intake across the state and launched a statewide client helpline and online intake application. We're using the latest technology to provide free legal education and self-help materials.

"It's hard to imagine Legal Aid of North Carolina without George," said Gonzalo E. Frias, Chair of Legal Aid NC's Board of Directors. "Heading into our 20th anniversary year, the organization is the strongest it has ever been—and that is due in large part to George's steady, tireless, and innovative leadership."

### Introducing HOP (Healthy Opportunities Pilots)

HOP is one aspect of the transition of Medicaid in North Carolina from a fee-for-service model to a managed care model. Under this new model, most Medicaid beneficiaries in our state now receive services through NC Medicaid Managed Care Health Plans. Medicaid recipients are also now required to be provided with more holistic services. That's where HOP comes in.

If problems related to housing, food insecurity, transportation, or interpersonal violence are identified, Medicaid managed care beneficiaries may be offered a referral to additional services to address these issues. Care managers and care providers may refer people who are eligible. You can also refer yourself to HOP.



Legal Aid NC is a HOP referral partner for people experiencing difficulty with housing and interpersonal safety. We may be able to help you with legal remedies to health injustices.

### How do you know if you may be eligible for free HOP services?

- You must be enrolled in Medicaid Managed Care and live in one of the 33 North Carolina counties in which the pilot program is currently operating. [Visit \[ncdhhs.gov/media/14070/download?attachment\]\(https://www.ncdhhs.gov/media/14070/download?attachment\) to see if your county is on the list.](https://www.ncdhhs.gov/media/14070/download?attachment)
- You must have at least one qualifying physical or behavioral health condition. Examples include being an adult with two or more qualifying chronic conditions such as diabetes or being a neonatal intensive care unit graduate who is younger than age 3.
- You must have at least one qualifying social risk factor such as food insecurity, being homeless or at risk of losing housing, lacking transportation to access basic needs and services, or being at risk of witnessing or experiencing interpersonal violence.

### What kinds of help can you get through HOP using your Medicaid health plan?

If eligible, you can receive help in the four categories of housing, food, transportation, and interpersonal safety. Specific examples of help available in each category include:

**Housing:** One-time payment for security deposit and first month's rent.

**Food:** Healthy food boxes and medically-tailored meal delivery.

**Transportation:** Bus passes and taxi vouchers.

**Interpersonal safety:** Case management/advocacy for victims of violence.



### Legal Aid NC Strategic Framework Contains Multiple DEI Components

In the Strategic Framework adopted by our board last year, we set forth many objectives and action steps in support of our mission and vision. One of our primary strategic objectives as an organization is to integrate an understanding of diversity, equity, and inclusion issues into all aspects of our work.

To support this objective, we've pledged to improve cultural humility and competency among our staff, Board, and volunteers. Legal Aid NC staff are also committed to evaluating program opportunities through a diversity, equity, and inclusion impact lens. In 2021, we hired our first DEI officer, Tonia D. Trammell to spearhead our efforts to achieve this two-pronged approach. She brings more than 10 years of DEI experience and a passion for equity to the position.

When Trammell conducted a DEI assessment with Legal Aid NC staff, she found they generally feel that their work environment is supportive and inclusive. Cultural competency trainings, as well as Town Hall meetings, are provided as we strive for continual improvement in the area of DEI and seek to expand our capacity to serve clients. Trammell also sends an e-newsletter to staff called Inclusive that provides key local and national news regarding DEI.

Ensuring that the Legal Aid NC staff is diverse and culturally competent is foundational to cultivating professional excellence. In addition to providing DEI training, we continue to hire outstanding staff who reflect the diversity of our clients and our community.

### Legal Aid NC Stands Up for Students and Their Families

The Right to Education Project (REP) is a statewide effort focusing on protecting the rights of children in public schools. Among other related issues, REP cases address suspension, expulsion, bullying, and discrimination on the basis of sex, race, disability, or national origin.



In addition to providing direct legal services to clients, REP offers community education in the form of publications, presentations, trainings, and media outreach. Free videos and toolkits available online provide detailed information on a wide range of topics related to the education rights of students. ### Legal Aid NC Files Federal Complaint for Black Student Against Davidson Co. Schools

In March 2022, REP filed a federal complaint with the U.S. Department of Education's Office for Civil Rights on behalf of a 14-year-old Black student and her family against Davidson County Schools (DCS). The complaint highlights a pervasive pattern of racial discrimination and harassment experienced by the student while attending Oak Grove High School during the 2021–2022 school year.

Multiple incidents over the course of three months included failing to discipline a group of white students for openly discussing pronunciation of the word "n\*gger" in our client's presence and then calling her "a n\*gger" and failing to aid our client or allow her to call her mother while she suffered an extended anxiety attack caused by discriminatory treatment.

The remedies Legal Aid NC seeks on behalf of the student include a comprehensive investigation by the Office for Civil Rights of all the incidents we documented in the complaint and appropriate and timely discipline of all DCS administrators, faculty, and staff members who violated the student's rights, DCS policies, and DCS expectations of employee conduct.

## Announcing New Legal Aid NC Office in Pasquotank County

### Elizabeth City Office Opened January 2022

Sheriff's deputies shot and killed Andrew Brown Jr. in his car in 2021, and his death sparked days of protest in Elizabeth City. As local residents continued to cope with this tragedy, Legal Aid NC opened an office as a signal of our commitment to help provide justice to a community badly in need of it.

"This community has experienced turmoil," said Reynald Williams, senior managing attorney of our Ahoskie office, which serves Pasquotank and 10 other counties in northeastern North Carolina. "Half of Elizabeth City residents and a third of Pasquotank County residents are African American."

Williams continued, "City leaders invited us to open this office in hopes that the justice we provide to those impacted by poverty can help with the healing process. Our presence here wouldn't be possible without the support of Mayor Parker and the City Council, and two generous donations from anonymous donors."

Two attorneys and one paralegal staff the new office, which is a satellite of our Ahoskie location. While Legal Aid NC has always served residents of Elizabeth City and Pasquotank County, Legal Aid NC staff can now work more closely with community leaders and partner more effectively with other service organizations. Local residents can much more easily access the new location at 524 S. Road St.



"We want to be a strand in the fabric that holds this community together," said Max Baker, one of two attorneys in the office. "Everyone in Elizabeth City and Pasquotank County should know that we are here for them. If you're struggling with eviction or other housing issues, domestic violence, public benefits, consumer issues and more, come to us for help."



## Client Stories

### Legal Aid NC helps Veteran Obtain Benefits

While on temporary Army duty in California in the 1970s, our client witnessed—and believed he caused—the death of a fellow soldier. His mental health suffered as a result. He filed for compensation in 2012 but was denied due to lack of evidence of the triggering event. The client couldn't remember the name or any identifying information regarding the dead soldier, and his military records contained no reference to the event. Nobody, including VA personnel, believed his story.



A Legal Aid NC advocate conducted significant research into the claim and eventually located a back-page article from a defunct newspaper on microfiche in a public library. We assembled evidence, and the VA reopened the claim and granted service-connected compensation. The client's estimated tax-free benefits over the next 10 years will exceed \$118,000, including more than \$45,000 in back payments.

### Legal Aid NC Protects and Support Victims of Domestic Violence

Domestic violence is one of Legal Aid NC's largest practice areas, and 75% of our clients are women. When Alicia came to us, she was working hard to provide for her children while feeling trapped in a violent relationship. She tried to file for a Domestic Violence Protective Order on her own but wasn't successful.

A Legal Aid NC advocate helped her secure an order and then assisted her with clearing her name from false claims her abuser had filed against her. Alicia needed access to other crucial services to create a stable life for herself and her kids, and a Legal Aid NC team from our Battered Immigrant Project
