Ashley Campbell is the CEO of Legal Aid of North Carolina (LANC). She began her career at LANC in 2003 representing clients in the areas of landlord tenant and domestic violence. In 2005, Campbell worked at the N.C. General Assembly as a non-partisan staff attorney in the Bill Drafting division and committee counsel to the House Finance Committee. In the years that followed, Campbell became an experienced real estate and commercial litigator at Ragsdale Liggett.

She transitioned her practice to Campbell Law School in 2016, where she served as director of the Blanchard Community Law Clinic. Today, Ashley leads 450 legal aid staff whose mission is to provide access to justice for more than two million eligible North Carolinians.
